PASSPORT BOOK

For international travel by air, sea, or land. The passport book is REAL ID compliant and can be used for domestic air travel.

PASSPORT CARD

ONLY used for land and sea travel between the U.S. and Canada, Mexico, Bermuda, and the Caribbean. The passport card is not valid for international air travel.

RENEWALS

Renew by mail using form DS-82. Find applications at Travel.state.gov.

To be eligible, all of the following conditions must apply:

- · Submit most recent passport.
- At least 16 years old when the most recent passport was issued.
- Issued the most recent passport less than 15 years ago.
- Same name as on the most recent passport, or submit documentation of name change by marriage or court order.

ADDITIONAL REQ.: 15 YEARS & UNDER

- Proof of relationship to child.
- Both parents and child must appear in person or a parental consent form by the absent parent is required.

BIRTH CERTIFICATES

Must be a certified copy and include all of the following: Full given name, date of birth, place of birth, signature of the registrar, authorized seal of the Registrar's office, filing date within one year of the birth. Note: California Abstract Birth Certificates and photocopies are not acceptable.
