



LANDSCAPE PLAN APPLICATION

Pursuant to California's Model Water Efficient Landscape Ordinance (MWELO) and Glendora Municipal Code (GMC) §6.10.120, projects requiring a building permit or Planning approval, plan check, or landscape design review with a landscape area greater than 500 square feet or rehabilitating an existing landscape area greater than 2,500 square feet are required to submit a Water Efficient Landscape (WEL) Application and related documents and certification forms.

To process the application, please submit the following:

 - ☐ Planting Plan
 - ☐ Fuel Mod Plan Approved by Los Angeles County Fire Department

 - ☐ Grading Plan
 - ☐ Water Efficient Worksheet
(available in the Water Efficient Landscape and Irrigation Application Package)

All landscape plans subject to MWELO, as well as the WEL application and related documents and certification forms are required to be completed by a landscape design professional.

Property owners, developers, and landscape design professionals are encouraged to thoroughly review the packet to understand all requirements.
