



CITY OF GLENDORA REBATE PROGRAM



QUALIFICATIONS

- Rebates only available for qualified devices. Applicants must be a Glendora water customer. **Suburban Water Systems customers DO NOT qualify.**
- Item(s) **MUST** be installed at the address listed on your Glendora water bill and application.
- Application **MUST** be received within six (6) months of qualifying purchase date.
- All items and/or projects **MUST** be installed and completed prior to submitting application.
- Rebates only issued to the water customer. Applications cannot be submitted by a third-party.
- Rebate amount not to exceed purchase price plus tax (does not include shipping & handling fees).
- Rebates are available to all Glendora water customers, including residential and commercial accounts.

TERMS & CONDITIONS

- The City reserves the right to verify and inspect rebate devices.
- Funding is limited. Submitting a rebate application does **NOT** guarantee you will receive a rebate. Rebates issued on a first-come first-serve basis until funding is exhausted.

Terms and conditions below only apply to the Landscape Professional Services Reimbursement Program

- Rebates are limited to 1 designer and 1 installer per site, capped at \$1,000 or the total design/installation cost. Projects submitted through SoCalWaterSmart, Metropolitan Water District's Turf Replacement Program, before July 1, 2024, are not eligible.
- New construction projects are not eligible. Program is exclusive for MWD program participants.
- By participating in the Landscape Professional Services Reimbursement Program, you release the City of Glendora and their agents from any claims related to the design, installation, or use of devices in connection with the program. Any issues with services or devices should be addressed with the designer, contractor, or manufacturer.

HOW TO APPLY

The following items must be submitted:

- Completed application form
- Copy of sales receipt
- Copy of landscape plan and 1 photo of the new landscape.
 - Only applies to the landscape related rebates.
- Copy of your Glendora water bill
